## Report on Business

#### a) In its Global Private Enterprise Business Line:

- i. RIWI continues to complete project milestones and to respond with costed new proposals for data collection on behalf of its client, a top-10 international bank, pursuant to the Company's three-year long-term agreement.
- ii. Following a successful pilot project, RIWI is working with its client, a large US-based data provider to global finance institutions, on a long-term agreement requiring RIWI to complete global trend-detection projects on a recurring basis.
- iii. RIWI continues its work with one of the largest reinsurance companies in the world that sells a predictive risk product to the reinsurer's clients around the world. RIWI is the data supplier for this product.
- iv. RIWI continues its work under its long-term agreement with an existing client, Omidyar Network, a US-based social impact investment firm, to assess changing consumer needs on a variety of topics.

#### b) In its Global Security Business Line:

- i. RIWI continues working on a multi-year engagement with a G-7 government agency in the field of international security. The client is collaborating with RIWI to cost and prepare work for new and diverse services over the next five years.
- ii. RIWI continues work for the US Department of State in its 5-year agreement.
- iii. RIWI continues to respond to inbound requests for priced work proposals.

#### c) In its Global Citizen Engagement Business Line:

- i. Following competitive tender and technical compliance review, RIWI was awarded an exclusive long-term agreement by one of the top Universities in the world (as measured by *US News & World Report*) for global digital surveying and digital outreach services. The agreement enables rapid procurement by RIWI with any of the University's departments and lasts until 2022; the client has an option to renew the agreement for two subsequent one-year terms. RIWI has started work on its first contract issued under this agreement.
- ii. RIWI has won an extension of its long-term agreement with the UN World Food Programme, for data collection in over 70 countries, to last until 2020.
- iii. RIWI was awarded new work by various clients, including the UN Food Programme, the World Bank, Freedom House and the Government of Canada.

- 2. Provide a general overview and discussion of the activities of management.**
- a) RIWI management continues to present its offerings for sales purposes in public and client forums, such as the World Bank, Freedom House and specialty conferences.
  - b) For sales purposes, management promotes new reports about RIWI findings and its technical capabilities published by clients and third parties. Recently these reports have included: *Africa Data Revolution Report 2018* published by the World Wide Web Foundation; a Harvard University article authored by the CEO of SAGE; a publication by the thinktank, Friends of Europe, written by the CEO of International Alert; and a peer-reviewed paper (in press) on RIWI authored and led by Honda's head of research and analytics in the *International Journal of Business Innovation and Research*.
  - c) For sales purposes, management cites high-profile media about RIWI findings. This month the Prime Minister of Israel discussed RIWI findings on trends in the Middle East in a wide range of media. RIWI data for financial analysts predicting stock trends were noted in financial media, including thefly.com and cnbc.com.
  - d) RIWI has advanced its all-country election services package, presenting its offerings clients in different jurisdictions and to global financial services institutions.
  - e) RIWI continues to increase its sales presence in the global insurance industry.
